ROBERT JEKYLL AWARD FOR LEADERSHIP IN CRAFT



The Canadian Crafts Federation / Fédération canadienne des métiers d'art (CCF/FCMA) invites the craft community to put forward nominations for the Robert Jekyll Award for Leadership in Craft. This award celebrates respected contributors to the craft sector, and it is one of the highest markers of exceptional commitment to development of the craft community in Canada.

CALL FOR NOMINATIONS

THE ROBERT JEKYLL AWARD FOR LEADERSHIP IN CRAFT

Eligible Nominees

Nominees must be respected contributors to the craft sector, having dedicated significant time (suggested minimum: ten years) and energy to the movement and development of the contemporary Canadian craft sector. This may include craftspeople, artists, designers, administrators, curators, collectors, educators, volunteers or any other category related directly to the craft field. Recipients will be chosen based on the impact they have had in advancing the respect for and recognition of the craft sector. National and/or international impact is preferred, however regional impact at a provincial or territorial level will be considered. Current Board members cannot be nominated with the exception of Past President.

Eligible Nominators

[Craft Council and Affiliate Members](#) in good standing with the CCF/FCMA, past Robert Jekyll Award recipients, and the CCF/FCMA Board of Directors are eligible to submit a nomination. If you are a current member of a Provincial or Territorial Craft Council in Canada, then you are eligible to nominate one worthy candidate. Previously unsuccessful nominations may be submitted for consideration a maximum of three consecutive years.

Nominations Must Include

- A completed copy of the nomination form (attached)
- A letter of nomination, written by an eligible nominator or an authorized representative of an eligible nominating organization. The letter should answer the following questions:
 - What are the attributes and accomplishments of the Nominee that makes them worthy of the Robert Jekyll Award?
 - What are the experiences in the Nominee's background that they bring to the craft sector, perhaps from another sector?
 - What is the Nominee's connection to the nominating organization, if applicable?
 - Can the Nominee be expected to make any future contributions to the sector?
- A copy of your Nominee's professional CV in relation to the award.

Successful Nominees will be required to submit a high resolution photo headshot and a one-paragraph biography.

Nomination evaluations will be based on, but not limited to, the Nominee's:

- Contribution to craft community development (professional practice, community recognitions, community impact, service work, volunteer work, etc.).
- Governance activity (service on boards or with craft based organizations, etc.).
- Advocacy activities (at regional, provincial/territorial, national and/or international level).
